- Indicate registration status with CIPC & bank account (optional).
- Must have own transportation to and from the venue located in Bergville Sport complex.

- Interested exhibitors will be required to:
 - Have Marketing/ Promotional (pamphlets and/or business cards) material.
 - At least have one person manning their stand throughout the 2 days initiative at all times
- Exhibitors will be permitted to display banners and products in their respective stands.
