A nominator, providing substantive motivation, must nominate the proposed candidate in writing, and the proposed candidate must accept such nomination in writing, in addition to which the nominee must submit:

 A detailed Curriculum Vitae (CV); · Certified copies of qualifications;

· Certified identity document; · An affidavit that she or he is not disqualified from being a director; and · Supporting information and contact details of at least two (2) references, failing which the nominee will be disqualified and will not be considered for appointment.
