WRITTEN REPLY

NO. 155/2021 MR C J PAPPAS (DA) TO ASK THE MEC FOR ECONOMIC DEVELOPMENT, TOURISM AND ENVIRONMENTAL AFFAIRS ON HOWICK FALLS

IN RELATION TO THE SOPA ADDRESS 2021 WHERE THE PREMIER SPOKE OF THE HOWICK FALLS PRECINCT DEVELOPMENT:

1. HOW MUCH (IN RANDS) HAS BEEN ALLOCATED TO PLAN AND IMPLEMENT THIS PROJECT?

The Department had initially allocated an amount of R4 million for the project which was revised to R5 million during the 2020/21 financial year. It is estimated that the planning phase will not cost more than R 300 000 which will include Architectural design and Bill of Quantities (BoQ). The balance of R 4, 7 million will be utilized for the actual implementation and professional fees as covered in Q6 below. However, should there be any budget short fall, other activities/deliverables listed in question 6 will form part of phase two implementation and additional funding will be sourced internally from the department or from other stakeholders such as the National Department of Tourism to ensure the completion of the project.

2. WHO IS THE IMPLEMENT AGENT/DEPARTMENT?

The Department through UMgungundlovu District Municipality has appointed UMgungundlovu Economic Development Agency (UMEDA) as an implementing Agent for the project and funds have already been transferred to the Agency during 2020/21 financial year.



3. WHEN WILL THE PROJECT BREAK GROUND?

The Implementing Agent is currently in the process of appointing an Architect to design and prepare the entire precinct plans for implementation. This process is anticipated to take a period of two months (June and July 2021) should there be no delays.

4. WHEN WILL THE PROJECT BE COMPLETED?

It is anticipated that the project will be completed in June 2022 should there be no delays.

5. WHEN WILL THE PLANS BE MADE PUBLIC?

The plans will be made available to the public upon finalization and approval in August 2021 should there be no delays. The planning phase is expected to take a period of two months (June to July 2021).

a. IF THEY ARE PUBLIC WHERE CAN THEY BE OBTAINED?

The plans will be available for viewing from the Umngeni Local Municipality upon completion and approval in August 2021 should there be no delays.

6. WHAT DOES THE PROJECT ENTAIL?

The project entails the development, installation, construction of bulk infrastructure, upgrade and maintenance of tourism facilities, and other amenities within the Howick Falls precincts listed as activity/deliverable in table (a). These activities /deliverables will be funded through an estimated implementation budget as highlighted in Q1.
