IN WHICH CATEGORY DO I REGISTER?

KZN Database of provincial tourism service providers is regarded as the most comprehensive of its kind in the country. It is essentially an inventory of all tourism-related services and is composed of 17 categories, which range from accommodation establishments and conference venues or organizers to recreation and entertainment activities. Restaurants, sporting facilities, historic and cultural assets are also included.

SO THAT'S WHAT IT DOES FOR YOU...NOW WHAT DOES IT DO FOR EDTEA?

The registration system ensures that EDTEA/ TAFA has your records and that they are up-to-date. This helps us provide comprehensive and accurate information to our visitors. Our database also forms the backbone of tourism research, communication, marketing; and information dissemination in the Province. Through our excellent Customer Care programme, our visitors also benefit by having a channel through which to lodge complaints or compliments about the services utilized during their stay in our beautiful province.

DO I HAVE TO REGISTER?

Regulations were promulgated on 13 May 2004 in accordance with the KwaZulu-Natal Tourism Amendment Act, 2002 making registration with EDTEA mandatory for all tourism establishments and tourism operators. (See regulation attached for Ease of reference)

GUIDELINES FOR REGISTRATION

<u>PLEASE NOTE</u>: It is important to take note of these guidelines for the registration of tourism establishments and tourism operators. Failure to comply with these guidelines will result in EDTEA rejecting your application.

URGENT NOTICE

According to regulations that were promulgated on 13 May 2004 under section 32(f) and (i) of the KwaZulu-Natal Tourism Amendment Act, 2002. It is mandatory for enterprises whose **primary** object is to provide services and facilities to tourists in the province of KwaZulu-Natal.

THE FOLLOWING DOCUMENTS MUST BE SUBMITTED

- 1. A completed and signed registration form for <u>each</u> sub-category in which you wish to register as per the category list attached (see attached);
- 2. A signed code of conduct (see attached);
- 3. **Proof** of payment of R150.00 for **each** sub-category in which you wish to register as per the category list attached (registration fee is payable every year upon renewal);
- 4. Proof of business licence (certificate of registration from the Registrar of Companies if for example your business is registered as a Cc, Pty Ltd. etc. In the case of a Sole Proprietorship or a Partnership, where certificates cannot be produced, please contact our offices for a <u>declaration form</u> which must be signed and sent back to our offices). Where applicable, proof in this regard from your local municipality must be submitted to our offices, as well as a trading licence;
- 5. Proof of public liability insurance (if applicable to your business). *Please note that an exemption can only be granted if there is no such cover available by insurance brokers for the type of business that you are operating:
- 6. Seven pictures and a registered trademark/logo of your business/establishment for the website, if applicable; and
- 7. Proof (letter/certificate) of membership with at least one local Community Tourism Organisation (CTO) A Community Tourism Organisation means an independent local organisation registered with the Authority, responsible for the promotion of tourism establishments and tourism operators within a local area, within the Province. Please contact EDTEA office on Tel: 0332649326/21/22/18 should you require a list of CTO's in KZN.
- 8. If you are registering as accommodation booking agent, you must please ensure that in addition to providing the above-mentioned documents a list of the establishments/units for which you are making bookings is also attached to your registration application.

Please provide as much detail as possible regarding your service in the description field on your registration form e.g. whether you are a member of SATSA, whether your establishment has been graded by the SABS, Tourism Grading Council of South Africa or the Portfolio of Country Places, the number of delegates your conference venue can hold, a tour operator's field of specialization etc.

Where applicable, please submit proof of registration for PAYE, VAT, business levies and valid tax clearance certificate from relevant authorities.

FAILURE TO REGISTER

Any tourism establishment or operator that has been found guilty of having contravened the regulations may be liable: For a fine not exceeding R10 000;

To have your registration suspended for a period not exceeding three years: or

For both such a fine and suspension of your registration.
