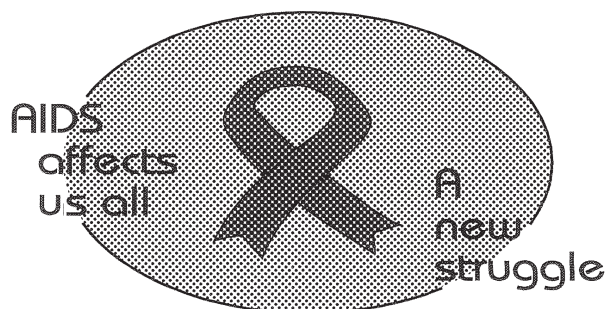

By virtue of the powers vested in me as the Member of the Executive Council for Economic Development, Tourism and Environmental Affairs in terms of Section 5 of the KwaZulu-Natal Trade and Investment Agency Act, 2010 (Act No. 5 of 2010) hereinafter referred to as the Act, I hereby invite any interested parties to nominate candidates for appointment to the Board of Directors of the KwaZulu-Natal Trade and Investment Agency.

Trade and Investment KwaZulu-Natal, is a listed provincial public entity in terms of the Public Finance Management Act schedule C and operates under the Kwa-Zulu-Natal Department of Economic Development, Tourism and Environmental Affairs (KZN EDTEA). The entity's mandate is to position KwaZulu-Natal (KZN) as a premier investment destination as well as to promote trade, particularly to increase exports from the province.

**To qualify for nomination, person(s) must be fit and proper, and must–**

- (a) have appropriate knowledge or experience in organised constituencies within the business industry;
- (b) the person must not be disqualified from being a director of a company;
- (c) must meet the requirements for appointment as contemplated in section 94 of the Companies Act, 2008;
- (d) must meet the requirements for independence contemplated in King IV Report on Corporate Governance
- (e) the candidate must have demonstrable Corporate Governance experience; and
- (f) possess one or more of the following skills, experience and qualifications:
  - (i) Legal skills, experience, and qualifications
  - (ii) Financial skills, experience, and qualifications;
  - (iii) Investment and export experience or qualifications;
  - (iv) Labour market experience or qualifications;
  - (v) Human resource or educational experience or qualifications;
  - (vi) Community development skills and experience; and
  - (vii) Planning or development skills and experience.

Nominees should familiarize themselves with the provisions of the KwaZulu-Natal Trade and Investment Agency Act, 2010 (Act No. 5 of 2010) relating to disqualification from being appointed to the TIKZN Board as provided in Chapter 3.

**Nominations must be in writing, accompanied by a signed Nomination Letter from the Nominator and Acceptance Letter from the Nominee, in addition to which the Nominee must submit:**

- a) A detailed Curriculum Vitae (CV);
- b) Certified copies of all qualifications and Identity Document;
- c) An affidavit stating that she or he is not disqualified from being a director in terms of Section 6 of the Act;
- d) Declaration of Interest: Nominees must, within 10 days of being nominated, submit a written declaration of all direct or indirect interests in any company or other business interests. Failure by the nominee to disclose financial and other interests disqualifies such nominee in terms Section 6 of the Act to be considered for the position of the member of the Board; and
- e) Any other supporting information that may assist the MEC in considering the nomination, including contact details of at least two (2) references.

**Failure to submit all documentation from (a) to (e) will result in disqualification from this nomination process.**
