THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME (SBD 5)

INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

1 PILLARS OF THE PROGRAMME

1.1 The NIP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$ 10 million or other currency equivalent to US\$ 10 million will have a NIP obligation. This threshold of US\$ 10 million can be reached as follows:

- (a) Any single contract with imported content exceeding US\$10 million.
or
- (b) Multiple contracts for the same goods, works or services each with imported content exceeding US\$3 million awarded to one seller over a 2 year period which in total exceeds US\$10 million.
or
- (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US\$10 million.
or




4. SPECIAL CONDITIONS OF CONTRACT

4.1 LIABILITY

The contractor shall be liable for the acts and omissions of its personnel and /or employees in the execution of their duties against:

4.5 EXECUTION OF WORK

The service rendered shall be carried out by the Contractor in a thorough and workman manner and to the satisfaction of the Department.

4.6 INSPECTION OF SITE

The Contractor shall have inspected the site and to have satisfied himself / herself before submitting his bid, as to the nature of the work amount of personnel required and material necessary to render the service as required in the bid document.

4.7 CARE OF THE WORKS

The obligation to take care of and provide custody for the contract work and everything connected therewith shall rest solely with the Contractor who shall take all necessary precautions to prevent injury to persons or damage to property and to protect adjoining properties from trespass or damage to progress of the contract.

4.8 REMUNERATION

- 4.8.1 The Department shall remunerate the Service Provider in respect of its services in accordance with the appropriate conditions as set forth.
- 4.8.2 The Service Provider agrees hereto that responsibility of payment for services rendered to the Department shall vest in the Service Provider, who shall on monthly basis submit an invoice to the Department.
- 4.8.3 The service Provider shall submit to the Department a tax invoice for each month, and the Department shall pay to the Service Provider the amount of invoice within 30 (thirty days) of receipt of an agreed invoice. All supporting documents must be attached to all invoices submitted.
- 4.8.4 In the event that the Department is not satisfied with the performance of the Service Provider, the Department shall give written notice to this effect to the Service Provider providing sufficient detail and a reasonable time frame to enable the service provider to rectify such performance.

- 4.8.5 In the event of the entire amount or a portion of the invoice being disputed by the Department, only a portion in the dispute shall be held for payment, until the dispute is resolved. The undisputed portion shall be paid to the Service Provider within the stipulated time frames.
- 4.8.6 International and Domestic Travel to be undertaken by the service provider shall be as per the Travel Policy of the Department.
- 4.8.7 Disbursements shall be claimed as per the Subsistence and Travel policy of the Department.
- 4.8.8 The Service Provider shall immediately give notice of any circumstances preventing it from completing its obligations in terms of the contract.

4.9 TERMINATION OF SERVICES

- 4.9.1 Should the Contractor fail to meet the conditions of the contract, or continue rendering unsatisfactory service, the Department reserves the right to terminate the contract, after written notification has been served on the Contractor, with retention of the right to recover from the Contractor any losses which the Department may suffer/ incur as a result of the failure, without prejudicing any other rights it may have.
- 4.9.2 The Department reserves the right to terminate the agreement, should the Institution, for any reason, be permanently closed or transferred to another location.
- 4.9.3 KZNEDTEA reserves the right to terminate the contract of any assignment to any party if there are reasonable grounds for considering that there is non-performance by the contracted service provider.

ANNEXURE B: GENERAL CONDITIONS OF CONTRACT

**GOVERNMENT PROCUREMENT:
GENERAL CONDITIONS OF CONTRACT
July 2010**

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

General Conditions of Contract**1. Definitions**

The following terms shall be interpreted as indicated:

- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.

- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any Bidder, and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25 "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of Contract Documents and information; inspection.

- 5.1 The supplier shall not, without the purchaser's prior written consent disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance Security

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful Bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1 All pre-bidding testing will be for the account of the Bidder.
- 8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the Bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.

- 8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental Services

13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.

17. Prices

- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

18. Contract Amendments

- 18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned

19. Assignment

- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under these contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.
- 21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in

substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

- 23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

- 23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

- 24.1 When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies

28. Limitation of liability

- 28.1 Except in cases of criminal negligence or wilful misconduct, and in the case infringement pursuant to Clause 6;

- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing Language

- 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable Law

- 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

31. Notices

- 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any Bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the Bidder. This certificate must be an original issued by the South African Revenue Services.

33. National Industrial Participation (NIP) Programme

- 33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.

34 Prohibition of Restrictive practices

- 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a Bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2 If a Bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.
- 34.3 If a Bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the Bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the Bidder(s) or contractor(s) concerned.

1.2 SUB-PROGRAMME OVERVIEW

The strategic objective of the Economic Empowerment Sub-programme is to create an enabling environment for economic development and empowerment of the previously disadvantaged individuals and groups (especially youth, women, people living with disability) to participate in the mainstream economy. It is further tasked to ensure that there is economic transformation in the Province of KwaZulu-Natal. The Sub-programme derives its mandate from the South African Constitution, National Development Plan, Broad-Based Black Economic Empowerment (B-BBEE) Act, Codes of Good Practice, Provincial Growth Development Strategy, KZN B-BBEE Strategy and other empowerment strategies.

The B-BBEE Act 53 of 2003 as amended regards empowerment of black people as a priority for radical economic transformation. It is on this basis that the KZN B-BBEE Strategy for 2008 was introduced. The central focus of KZN B-BBEE Strategy, among others, is to facilitate and co-ordinate stakeholders for B-BBEE policy implementation across all sectors of economy. Over the years the Department of Economic Development, Tourism and Environmental Affairs (EDTEA) has implemented various strategic initiatives to drive economic transformation in KZN. This includes the establishment of key structures as determined by the KZN B-BBEE. The following structures have been established since 2008: B-BBEE Advisory Council, B-BBEE Forums, and B-BBEE Implementation Teams. The Department has also entered into various strategic partnerships with the private sector and Government Departments in support of economic transformation and empowerment of target group. This includes, but not limited, B-BBEE Commission, MOU with the DTI on the Black Industrialists Programme.

In 2020/2021 financial cycle the the Department compiled the data-base of the KZN Black Industrialists to ensure that there is accurate information of the Black Industrialists (BI) in the Province. The Black Industrialists include companies that are 51% black owned from various sectors of the economy, and this is disaggregated in terms of gender, ownership, sector, geographical location, race (African, Coloureds, Indians).

It is against this background that the Department is interested in appointing an experienced Service Provider to conduct Business Profiling of thirty (30) Black Industrialist businesses in the KZN BI data base over a thirty-six months (36) period and, covering ten (10) BI businesses in each financial year cycle and develop turn-around strategies or recommendations of each of the BI businesses. EDTEA will identify the Businesses for Profiling from 95 business in the BI data-base.

1.3 INTRODUCTION AND BACKGROUND

Black Industrialist (BI) refers to Black South African entities directly involved in the production of goods and services at a large scale, with an interest of at least 51% in the ownership, management and operation of an industrial enterprise that acts to unlock the country's productive assets for massive employment. In 2017, the Department concluded an MOU with the DTI for the implementation of the Black Industrialists Programme in the Province. It was against this background that EDTEA started a process of developing the KZN Black Industrialists Implementation framework. This framework set clear Implementation objectives for the Province, and these are to:

- Prepare KZN enterprises and entrepreneurs to access National Black Industrialists opportunities;
- Establish KZN Black Industrialists Programme Management Unit;
- To provide enterprise and supplier development services;

- Facilitate access to market opportunities within Government and the private sector;
- Establish strategic linkages and partnership with the role players; and
- Provide Black Industrialist advocacy and information dissemination.

To achieve its purpose, the programme has been designed to include a series of interventions to build capacity of KZN Black Industrialists, conclude strategic partnerships with the private sector, Government/SOE or Public Entities to pursue radical economic transformation in the Province. These interventions include:

- Receiving and packaging Black Industrialist projects;
- Establish the KZN Black Industrialists Data base to enable access to market opportunities in the public and private sectors;
- Partnering with public and private sector stakeholders to enhance skills development and business support services; to improve the productivity and competitiveness of local Black Industrialists; and to cluster the potential Black Industrialists for market linkages;
- Improving existing, and developing new partnership mechanisms between institutions, sectors and levels of Government; and
- Connecting to National and Provincial policy processes to ensure that the context-relevance of the interventions is achieved and the dissemination of lessons learnt.

In 2020/21 financial cycle, the Department concluded the KZN Black Industrialists data-base of the top 100 operational KZN companies. This exercise revealed a lot of challenges faced by the KZN Black Industrialists as follows:

- Predevelopment challenges: lack of funding for feasibility studies, Environmental Impact Assessment (EIAs), Co-funding challenge with DTI grant funding;
- Lack of technical support on enterprise and supplier development;
- Lack of market access both within public and private sectors;
- The domination of various sectors by few major role players;
- Lack of material support;
- Lack of strategic partnerships;
- Lack of high-tech modern manufacturing machines; and
- The lack of land and infrastructure to operate their businesses.

This project is intended to address some of these challenges.

1.4 PURPOSE OF THE TERMS OF REFERENCE

The purpose of these terms of reference (TOR) is to conduct Business Profiling of thirty (30) Black Industrialist companies in the KZN BI data base over a thirty-six months (36) period and, covering ten (10) BI businesses in each financial year cycle and develop turn-around strategies or recommendations of each of the BI businesses. The TOR specifies the requirements of EDTEA to be responded to by potential bidders.

2. CONTRACT OBJECTIVES

2.1 WHY THE PROJECT IS IMPORTANT

This project is important for the implementation of the KZN Black Industrialists Programme in the Province. It is aimed at providing expert advice to the department on strategies to address the aforementioned challenges bedevilling the Black industrialist programme.

2.2 OVERALL OBJECTIVE

The overall objective of this project is to solicit the services of service providers to profile thirty (30) Black Industrialist businesses in the KZN BI data base over a thirty-six months (36) period and to develop comprehensive turnaround strategies of for each company in order to increase their operational efficiency and growth.

2.3 SPECIFIC OBJECTIVES

- i. To undertake a detailed profile to substantiate the aforementioned challenges and respective mitigating challenges of each company;
- ii. To undertake a detailed situational analysis of the current production, marketing and technological environmental under which these companies are operating;
- iii. Benchmark KZN BI programme with best practices in the country and beyond; and
- iv. To prepare a comprehensive turnaround strategy/recommendation for each of the profiled BI companies.

3. SCOPE OF WORK

3.1 SPECIFIC ACTIVITIES

3.1.1 Preparation of detailed profiles of each company to confirm the aforementioned challenges and respective mitigating challenges;

- i. **The specific objectives are to conduct site-visit for each of the 10 Black Industrialists businesses in order to assess each business on the following five broad strategic areas but not limited to:**
 - ❖ **Capacity building needs,**
 - ❖ **Access to funding;**
 - ❖ **Access to markets and partnerships;**
 - ❖ **Access to materials; and**
 - ❖ **Infrastructure and manufacturing equipments.**
- ii. **Understand the operational challenges faced by each company;**
- iii. **Propose mitigating challenges for all the challenges identified;**

❖ **Enterprise and supplier development required for the business**

The Department's aim at ensuring that there is business and technical skills development for potential Black Industrialists, especially to those who are not yet ready or meeting the requirement (R30 Million National threshold). The idea here is to provide various technical supports until they graduate to an Industrialists level. The activities envisaged from the successful bidder include:

- Identify the aspect of enterprise and supplier development needs for each company;

- Assessing each company's state of readiness in terms of compliance with regulatory requirements i.e. Environmental Impact Assessment, Feasibility Studies, Business Plans: are these concluded in order to access markets and partnerships
- Identify opportunities for each company along sector value chains thus ensuring that black industrialists are penetrating the mainstream economy.
- Identify support required by each company to sector value chains with potential for higher production volumes, efficient product development, and access to suppliers and buyers, joint marketing and other operations
- Identify Equity Equivalent opportunity for each company
- Explore public sector procurement opportunities for each company,
- Identify previous enterprise and supplier development training done by the company
- Identify supplier development opportunities for each company from public and private sectors;
- Identify relevant training institutions to support each business with training
- Identify possible training opportunities for each company such as the private sector net profit after tax for enterprise development
- Recommend tailor made capacity building for each of the BI company;

3.1.2 Drafting of a situational analysis of the current production, marketing and technological environmental under which these companies are operating;

- i. Understand production dynamics and bottlenecks faced by the company;
- ii. Prepare a detailed market assessment;
- iii. Analyze the current technological trends in the industry.

The activities envisaged from the successful bidder include:

- Assess the manufacturing machines for each company to determine whether it produce the required volumes,
- Assess the manufacturing infrastructure to determine if its conducive for its production capacity;
- Determine the technical experts utilize by each company for servicing the machines and costs associated with this,
- Analyse the impact of lease, water and electricity supply on the sustainability of each business.
- Analyse the barriers of infrastructure, manufacturing equipment's and make recommendations for possible implementation.
- To assess each company's state of readiness to access funding;
- Assess the needs for each company on pre-development funding such as co-funding
- Identify possible barriers and recommend the mitigations
- Assessment of material needs for each BI Company and determine where the materials is coming from,
- Assess the challenges and barriers for the material supply
- Determine the volume and the amount paid by each company
- Determine the possibility for localization of such materials if it is imported from outside

- Assess the cost associated with material supply for each company i.e. logistics, storage facility, etc.
- Identify additional sources of funding to leverage the BI initiative;
- Recommend how each company can prepare funding proposals to secure additional funding for BI initiative;
- Recommend how each company can lobby and negotiate with strategic partners to support BI initiatives;

3.1.3 Preparation of a Benchmarking report for KZN BI programme with best practices in the country and beyond

- **Benchmark each company with best practice in the industry or market in terms of the following areas but not limited to:**
 - **The level of enterprise and supplier development required for the business;**
 - **Access to funding;**
 - **Access to markets and partnerships;**
 - **Access to materials; and**
 - **Infrastructure and manufacturing equipments.**
- **Explore the development in other provinces and countries**

3.1.4 Drafting of comprehensive turnaround strategies/recommendations for each of the profiled BI companies.

- Turn around strategies must cover areas such as:
 - **Capital and machinery;**
 - **Technonolocal development;**
 - **The level of enterprise and supplier development required for the business;**
 - **Access to funding;**
 - **Access to markets and partnerships;**
 - **Training**
 - **Human resource expertise**
 - **Access to materials; and**
 - **Infrastructure and manufacturing equipments.**
- **Assess the financial implications of the turnaround strategy and possible funding instruments**
- **Prepare funding proposals for the most needs based on the turnaround strategies**

3.1.5 Provide administrative support to the work of the Project Steering Committee.

Please note that the Project Steering Committee (PSC) will include the successful Bidder, EDTEA and will be chaired by the Department. The activities envisaged for the PSC include:

- To utilize the TORs and SLA as a guide for the implementation of this project
- Receives and review progress report for this project
- Convene (through the designated Chair) at least monthly PSC meetings.
- The PSC should prepare monthly reports.
- The successful Bidder will be responsible for preparing financial reports for the PSC.

3.2 DELIVERABLES

- i. Inception Report
- ii. Situational Analysis and Benchmarking report
- iii. A profile for each of the 10 companies per year
- iv. A consolidated Close out report covering all the companies and their respective comprehensive turnaround strategies

3.3 PROJECT PHASING

The project will be undertaken in three phases i.e. the inception phase, implementation phase and close out phase:

3.3.1 Inception Phase

During this inception phase, the service provider should familiarize themselves with the BI initiative and focus on developing necessary systems and procedures. The activities involved in this phase should inter-alia include the following:

- Present Black Industrialists high level challenges

- Prepare 10 BI files incorporating above;
- Prepare and produce Phase 2 progress report.

3.3.2.4 Turnaround strategies

- Propose practical turnaround programmes/ strategies for each company in need;
- Develop funding proposals to include assessment of funding needs;
- Facilitate matched funding for BI (i.e. match BI with potential funders);

3.3.3 Close-out Phase

The Service Provider will prepare a detailed closeout report and hand over the KZN Projects Packaging report on 4 hard copies and on electronic version to EDTEA and 10 BI files. The report must highlight lessons learnt and how possible BI profiling can be improved. The Service Provider should further provide a report with detailed learnings drawn from the project implementation.

4. LOGISTICS AND TIMING

4.1 ANTICIPATED TIMEFRAMES

This project shall be implemented over thirty-six months (36) period, covering thirty (30) Black Industrialist projects made up of ten (10) BI projects in each financial year cycle.

5. TECHNICAL TEAM COMPOSITION

The Service Provider must have the following key experts:

- Project manager;
- Finance and Strategic Partnership Co-ordinator; and
- Business Development Co-ordinator.

The proposal should provide a detailed description of the team composition and Curriculum Vitae (CVs) of all project team members. Please kindly note that team members who are submitted as part of the bid must be involved in the carrying out of the project. Should there be a need for replacements, substitutes must be of equal calibre and prior approval must be sort from EDTEA. The team should comprise of the key experts as listed above.

5.1 KEY EXPERT 1: PROJECT MANAGER

The Project Manager will be responsible for managing overall project implementation and report to EDTEA and Project Steering Committee (PSC). The Project Manager will coordinate project activities, administrative and financial functions related to staffing, implementation and management of the project.

The Project Manager will undertake any other activity that would be necessary to ensure the proper supervision and management of the programme. The Project Manager will perform, but not limited to, the following tasks:

- Accountability of the overall project;
- Coordination of project activities;
- Liaising with the department regarding the project;
- Managing the project functions within the overall project governance structures i.e. the PSC;
- Managing the Project office and staff;
- Ensuring regular, effective and efficient use of project resources within the EDTEA; approved plans and budgets;
- Ensuring that project deliverables, time frames are adhered to; and
- Consolidating data for the progress reports and financial statements for the PSC to approve.

The Project Manager must have:

- Post graduate degree in management, development studies or economics;
- The Project Manager should have long-term experience in economic transformation; development finance experience, experience in putting together funding proposals, institutional arrangements for cross-sector partnerships in empowerment; programme management; SMME development, economic empowerment concepts development; and
- At least 10 years of relevant experience in a lead position in the project management of economic transformation, development finance, conclusion of strategic partnerships, local economic development or empowerment projects and the planning, implementation and evaluation of technical assistance and capacity building programmes.

The Project Manager should possess the experience, skills, competencies and knowledge in the following areas: leading and managing multi-disciplinary technical teams; project development, management, monitoring; time management; planning and organising; report writing; budgeting and financial management; establishment of administrative, procurement and financial management and accounting systems; knowledge of deal structuring to empower the designated group; presentation skills; communication and networking; good interpersonal relations in economic transformation context; strong writing and oral skills in English and IsiZulu; analytical thinking and problem solving and computer literacy (Word, Power Point, Excel).

5.2 KEY EXPERT 2: FINANCE AND STRATEGIC PARTNERSHIPS

The Finance and strategic partnerships will be responsible for managing, coordinating, and the implementation of the project in cooperation with the PSC.

Specific Functions/Tasks

The Partnership and Finance Co-ordinator will perform, but not be limited to, the following specific tasks/functions:

- To assess each company's state of readiness to access funding;

- To undertake financial modeling;
- Assess the needs for each company on pre-development funding such as co-funding;
- Identify possible barriers and recommend the mitigations;
- Identify additional sources of funding to leverage the BI initiative;
- Recommend how each company can prepare funding proposals to secure additional funding for BI initiative; and
- Recommend how each company can lobby and negotiate with strategic partners to support BI initiatives.

The Finance and Partnership Coordinator must have a university degree in public finance, economics, development studies or a related discipline. The Finance and Partnership Coordinator must have at least 5 years' relevant experience in economic transformation. The Co-ordinator should have extensive knowledge of and experience with policy and financing issues related to public-private partnerships in economic transformation. Actual partnership working experience or B-BBEE deal structuring experience is an asset. Specific experience with economic transformation of catalytic projects will be an advantage.

The Finance and Partnership and finance Coordinator should possess the experience, skills, competencies and knowledge in the following areas: knowledge of economic transformation regulatory and investment in South Africa; practical, hands-on experience in one or more of the following technical areas: deal structuring, project packaging, feasibility studies; strong managerial skills, with a demonstrated track record of managing programs with a strategic vision and strong operational focus, strong interpersonal skills and demonstrated track record in working with interdisciplinary teams in an economic transformation environment; ability to communicate effectively (orally and in writing) with a diverse group of constituencies; strong knowledge of project cycle management; analytical thinking and problem solving and computer literacy (Word, Power Point, Excel).

KEY EXPERT 3: BUSINESS DEVELOPMENT CO-ORDINATOR

The Business Development co-ordinators will be responsible for managing, coordinating, and the implementation of the project in cooperation with the PSC.

Specific Functions/Tasks

- To assess and make recommendation for each business on their enterprise and supplier development needs;
- Preparation of Business Turnaround strategies and preparation of funding proposals;
- Identify supplier development opportunities for each company from private sector firms;
- Identify relevant training institutions to support each business with training;
- Identify possible training opportunities for each company such as the private sector net profit after tax for enterprise development; and
- Recommend tailor made capacity building for each of the BI company.

The Business Development co-ordinator must have an officially recognised university degree in development studies, economics, accounting or at least 5 years' experience in business development of previously disadvantaged group. The business development co-ordinator should have specific knowledge or experience of enterprise and supplier development strategies. Specific experience/knowledge of B-BBEE Code's requirement on enterprise and supplier development.

The Business Development co-ordinator should possess experience, skills, competencies and knowledge in the following areas: planning and organising; report writing; budgeting and financial management; knowledge of relevant South African legislation, policies and enterprise development approaches; presentation skills; communication and networking; good interpersonal relations in an intercultural context; strong writing and oral skills in English (ability to speak in IsiZulu); analytical thinking and problem solving and computer literacy (Word, Power Point, Excel).

5.3 FACILITIES AND RESOURCES TO BE PROVIDED

The bidder must ensure that the team is adequately supported and equipped to undertake all the activities required for this project and that the team be always available as and when required by EDTEA. The bidder must ensure that it cater for logistical support to the team such as travelling, and accommodation.

6. REPORTING

The overall management of the contract within EDTEA will rest with the Director: B-BBEE Operations. All reports will be prepared in an agreed format consistent with the activity and/or work plans. These reports should be submitted in electronic and print versions and where relevant be accompanied by a corresponding invoice. 7. TECHNICAL PROPOSAL

The Technical Proposals must include the following information.

7.1 Understanding of the Assignment

The geographical location of this project listing must be clearly indicated.

The evaluation of the above aspects will enable an assessment of the bidders' experience in the management of similar programmes and/or projects, their ability and capacity to manage a project of this nature, and whether any potential conflict of interest exists.
